Dear Vizsla Friend

The Hungarian Vizsla Welfare Charity was originally set up to rescue and re-home Vizslas that can no longer stay with their owners, for whatever reason. The HV Welfare Charity has since been involved in advising on matters relating to the welfare of Vizslas from puppyhood to veterans and research into various canine diseases. In 2012 a dedicated charity, Hungarian Vizsla Welfare Charity was registered by the Charity Commission and, as such, relies on donations from Vizsla owners, fund raising at Dog Shows and the generosity of friends and the public to cover the costs of providing kennelling, feeding and some retraining before Vizslas can be re-homed and in most cases require Veterinary care, which can be costly.

The Hungarian Vizsla is a highly intelligent, biddable and sensitive breed that requires regular exercise, mental stimulation and the love and affection of human company. You can help to relieve the stress caused during this interim period whilst a new suitable owner is found by making a donation towards kennelling, food, bedding, veterinary fees and retraining in preparation for its new home.
